- b. Core Curriculum revisions update.
  - Given by 2009-2010 Chair Jean Cook: The GenEd committee has a number of items on the table (most of which need to be handled ASAP). The committee must come up with the language and plans for three new BoR outcomes (Global Perspectives, US Perspectives, and Critical Thinking). A number of departments have come together over the summer to attempt to coalesce the current number of outcomes to a more manageable number. There is one old math course in the core that is no longer offered and needs to be switched out for another. UWG is required to have the 3 new outcomes and an evaluation plan in place by Fall 2011. All core outcomes must be approved by the GenEd committee, UAPC, Faculty Senate, and BoR core curriculum committee. Therefore, the committee should start work immediately. Last year, the committee was not formed until late in the semester. Jean still has the faculty survey and the minutes of the faculty forums for the next chair. More than one faculty members expressed that they wish a more senior member of the faculty were GenEd Chair.
